Are You Missing Out on Benefits?

Millions of older adults are having trouble making ends meet. Yet many do not realize help is within reach through underused money-saving public and private benefit programs.

When asked why they do not apply, many respond that they assumed they are not qualified. Or they may not be aware that there is a program to match their situation, whether it is financial help with utility bills, high-cost prescriptions, tax relief, caregiver support, and more.

If your budget is tight and getting tighter, now is a good time for you to see what kind of assistance may be available to help you. Here are a few ideas to help give your budget some breathing room.

The Homestead Exemption

The Ohio Homestead Exemption is a credit on property tax bills giving homeowners who live in their home an exemption of up to \$25,000 from all local property taxes. For example, through the homestead exemption, a home with a market value of \$100,000 is billed as if it is worth \$75,000.

To qualify, the homeowner must be age 65 or older by December 31 the year they apply. The Exemption is also available to qualified disabled citizens or surviving spouses. For 2023, the maximum adjusted gross household income is \$36,100.

Disabled Veterans may be eligible for Ohio's Enhanced Homestead Exemption

which exempts the first \$50,000 of the veteran's home value from taxation.

HEAP (Heating Assistance) Program

The Home Energy Assistance Program (HEAP) is a federally funded program designed to help eligible low-income Ohioans meet the high costs of home heating. To be eligible for this benefit program, you must have an annual household income (before taxes) below 60 percent of the State median Income as shown here:

NCOA's Benefits

Checkup makes it easy. Go to www.BenefitsCheckUp. org where you will enter your zip code (or any other area zip code in the U.S.) to discover what benefits are available in that area. You will then answer a few general questions to see if you qualify for any program

you are interested in learning more about.

If you have questions, please call their helpline at 1-800-794-6559, Monday–Friday, 9:00 a.m. to 5:00 p.m. for assistance. Even if you think you or an older adult you care for is not eligible for any benefits, it only takes a few moments to find out for sure.

Getting Help

There are many more benefits not mentioned here. Your local Area Agencies on Aging is devoted to helping older people perform benefits assessments or can refer you to other groups that conduct these evaluations. Contact your local Senior Center or your Area Agency on Aging to learn more.

Free COVID Test Kits

You may recall that last September, the distribution of free COVID test kits was suspended. However, the program has been renewed to help reduce the spread of the COVID virus this winter.

The fourth round of free at-home COVID tests are now available through the mail for every U.S. household.

How Do I Get My Test?

You can order your free at-home COVID-19 test kits online at www.covid.gov/tests. If you prefer, you can place your request for test kits by calling the U.S. Government's Covid 19 Hotline at 1-800-232-0233. Each household is eligible to order four free at-home tests. Special test kits for the visually impaired are also now

available upon request through the Hotline.

You will need to provide your name and mailing address. You will also have the option to share an email address if you would like updates on your order. All at-home COVID-19 tests will be mailed within 7 – 12 days directly to the address entered with their orders. No credit card or other information is needed.



Q. Does Medicare cover the shingles shot in 2023?

A. The CDC recommends adults 50 years and older get two doses of the shingles vaccine called Shingrix. It is more than 90% effective in preventing



shingles. Unfortunately, up until now, many people on Medicare have found the shingles vaccine to be unaffordable at up to \$200 per dose. This changes as of January 1, 2023.

All vaccinations – including the Shingrix vaccine – that are approved and recommended by the Centers for Medicare and Medicaid and the CDC, are now covered 100% under Medicare part D, without a co-pay. Give your physician's office a call to learn how you can get the Shingrix vaccine soon.
